MINUTES OF THE MEETING HELD ON TUESDAY 11^{TH} JULY 2017 AT 8PM IN THE VILLAGE HALL CLIFTON CAMPVILLE

2. **DECLARATION OF INTERESTS** – Cllr's Leedham and Pugh declared an interest in item d) on Planning.

3. MINUTES OF MEETING HELD ON 9TH MAY 2017

These were circulated prior to the meeting they were taken as read and signed as a true record. A copy of the minutes will be sent to John Bainbridge to put on the village web site.

4. MATTERS ARISING

Cllr. Leedham reported that the ditch in Netherseal Road is now clear.

a) Traffic Calming

Cllr. Starkey, Steve Riley and Cllr. Ingram had met with Highways to discuss the possible positions of the speed signs. Cllr. Starkey had also obtained quotes for the signs and the necessary works required. The Parish Council would ask for help with funding from Cllr. White. Matthew Ellis said that he thought there might be other parishes that would be interested in purchasing speed signs and if his office asked for a price for buying the signs in bulk then they might be able to get a good discount on the quoted price. This item was left with Matthew's office to contact all the other Parish Councils in the County to find out if they would be interested. Cllr. Starkey said he would pass on all the information that he has obtained to Matthew Ellis.

b) Telephone Kiosks

Work has started on the telephone kiosk in Clifton Campville, nearly all the old glass has been removed. Cllr Starkey has some more work to carry out removing the old putty and the resident who lives behind the kiosk has started to prepare the paintwork. There will be an approximate cost of £50 per kiosk for the preparation equipment required. The Parish Council agreed to this amount being spent. It was mentioned about either moving the current defibrillator to the kiosk or purchasing an additional one. Cllr. Bennion also said that they were thinking about installing a defibrillator in Haunton. The other idea was to use the kiosk for book swapping. The Clerk will enquire about the costs of a defibrillator with Keith Dawson. The work on the Haunton kiosk will start in the next few weeks.

5. MATTHEW ELLIS - Police & Crime Commissioner for Staffordshire

The Parish Council had contacted Matthew Ellis a while ago regarding rural policing. Matthew had brought along some hand-outs regarding a consultation about bringing the police and fire services together and an update newsletter. He then went on to talk to the Parish Council about how

policing has changed in the recent years with more money being spent on armed response on the roads because of the potential threat of terrorism and internet/technology crime. There will be an increase in rural policing, as there has just been a new chief constable employed and one of the objectives is to get more police out in the neighbourhood. Cllr. Leedham stated that the policing that we do see seem very disinterested in our problems. Particularly concerning burned out cars that had been stolen, set on fire and been left on his land. Cllr. Bingham also stated that he is concerned about drug use in Syerscote Lane. Matthew said to let his office and the local commander know about the problems the Parish Council has been having.
