A site meeting was arranged for Sunday 18<sup>th</sup> November 2018 to look at the Green in Haunton where the stones have been placed to prevent vehicles from damaging the grass.

It was decided that the council could not help at the moment due to other financial commitments. However Cllr. Ingram offered to cut the branch off the damaged yew tree the next day. Also a notice could go in the next newsletter asking for volunteers to help re-band the yew trees, to prevent them falling over the footpath. The Parish Council deferred helping with any funding for the works until the next meeting.
- h) Letter from Joanne Williscroft on behalf of Haunton BKV- Request for help funding new notice board for Haunton. The Parish Council agreed that they could not help on this occasion due to current expenses for the traffic calming and the tree felling works still to

be paid. However the Parish Council agreed to give a donation of £250.00 again next year towards the Best Kept Village entry, which has been included in the precept.

- **6. FINANCE** (As per attached transaction sheet) The Cllr's agreed to all the transactions being made.
  - a) Sign Clerks Expenses The Chairman signed the Clerks expenses.
  - b) Precept/Budget The Clerk had produced a draft precept/budget, which was circulated to all Councillors. It was agreed that the Parish Council would increase the precept to account for all items that have increased since last year, plus £850.00 for the tree works and set the special projects fund at £2,000.00. This would set the precept at £17,692.00.
  - c) The Clerk will ask the grass cutting contractor if he will reduce his price if the residents are cutting the green in Haunton.
  - d) David Lodge asked whether the Parish Council could ask for money back from Bromford as they provided funding for the parking bays at the front of the houses that have now been demolished. Cllr Fulbrook offered to look back through the minutes for any information regarding this funding.
